# Committee Roles:

#### Nominations and Leadership Development Committee:

The Nominations and Leadership Development Committee is responsible for finding, training, and supporting our lay leaders (non clergy and paid staff) in our church. They help the church council choose people for different roles and ministries, making sure we have the right leaders for our mission.

#### **Staff-Parish Committee:**

The Staff Parish Committee looks after the well-being of the pastors and staff, ensures harmony within the church community, supports their growth, and makes the final decisions on all matters related to staffing.

#### **Trustee Committee:**

Trustee Committee is responsible for the church's physical spaces and ensures they are well-maintained, safe, and in good shape for the congregation and community.

#### Finance Committee:

The Finance Committee takes care of the church's financial planning, management, and accountability to support the church's mission and ministries.

#### Service Committee:

The Service Committee works to spread compassion, support, and aid to those in need, both locally and globally, reflecting the church's commitment to outreach and making a positive impact beyond its walls.

#### Altar Guild:

The Altar Guild maintains the reverence and beauty of the church's worship space, ensuring that the altar area is appropriately prepared for events and services based on the liturgical church year.

### **Church Family Ministry Committee:**

The Church Family Ministry Committee is responsible for fostering community and cohesion between the worship services. It also seeks to care for those members who are not able to physically attend services due to poor health.

### **Spiritual Formations Committee:**

The Spiritual Formations Committee oversees the discipleship ministries of the church including Sunday School, Small Groups and the materials that foster spiritual growth and transformation.

### **Hospitality Committee:**

The Hospitality Committee is responsible for ensuring that everyone, especially guests feels valued, welcomed, and included in the church family.

## Church Membership and Archives Committee:

The Church Membership and Archives Committee is responsible for maintaining membership records and preserving the church's history.

#### **Technology Team:**
